महाराष्ट्र राज्यास ६,३७,०८९ इतके उद्दिष्ट प्राप्त झाले असून सदर उद्दिष्ट ग्रामीण विकास मंत्रालय, भारत सरकार यांचे मार्फत आवास सॉफ्ट प्रणालीवर जिल्हा, तालुका व ग्रामपंचायत निहाय वितरीत करण्यात आले आहे. तसेच या संदर्भात दि. १५ सप्टेंबर, २०२४ रोजी मा. पंतप्रधान, भारत सरकार यांच्या शुभहस्ते देशातील १० लाख लाभार्थ्यांना One Click मध्ये पहिला हप्ता वितरीत करण्यात येणार आहे.


Kindly refer to this Ministry's letters of even number dated 12th August, 2024 and 17th August, 2024 detailing the modifications approved by the Union Cabinet for the implementation of the PMAY-G during FY 2024-25 to 2028-29.

2. In this connection, I would like to inform that as per the Union Cabinet's approval, the eligible beneficiary households in the existing Awaas+ 2018 survey list would be saturated in this next phase of the scheme. For FY 2024-25, target of 40 lakh houses have been kept under the PMAY-G. Further, I would like to inform that the Ministry is in process of allocating targets to the States for FY 2024-25 and since, nearly 5 months of this FY 2024-25 have already elapsed, it is requisite that the process of registration of beneficiary households in the existing Awaas+ list is started so that the sanctioning and release of installment of assistance for the houses targeted for FY 2024-25 can be completed in a time bound manner after allocation of targets by this Ministry.

3. I would, therefore, urge you to kindly instruct the Officials concerned in implementation of the scheme at State/ District/ Block levels to start the process for registration of beneficiary households from the existing Awaas+ 2018 survey database on priority.

Madam/Sir,


As you are aware, the PMAY-G is being implemented in partnership with the State Governments to realize the noble goal of "Housing for All" in rural areas. The Union Cabinet had approved the continuation of the scheme for 5 more years till March 2029 for construction of additional 2 crore houses besides the completion of the remaining houses within the cumulative target of 2.95 crore houses allocated by this Ministry till 31.03.2024. I acknowledge and appreciate the efforts put in by the States in implementing the scheme and I am sure that similar zeal and enthusiasm would be exhibited by your State for assisting in time-bound achievement of targets set under PMAY-G.

2. In this regard, I would like to inform that with the approval of the competent authority in the Ministry of Rural Development, target of **25,50,743 houses** has been allocated from the existing finalised Awaas+ list to the 17 States under the PMAY-G during FY 2024-25. The State wise details are given in **Annexure**. The States having less than 1 lakh remaining eligible households in the existing finalised Awaas+ list have been considered for saturation and remaining States have been allocated targets in proportion of the remaining eligible households in the existing finalised Awaas+ list.

3. In line with the scheme's focus, the State is required to earmark at least 60% of the targets for SCs and STs subject to their availability in the Awaas+ database. It is also requested to finalize the district/block/GP-wise and category- wise targets in your State as per the User Manual on Awaas+ issued by the Ministry vide letter dated 15th July 2021.

4. It is, therefore, requested to kindly issue necessary instructions to all the Districts/ Blocks/ GPs within your State to fix the targets on AwaasSoft as per the User Manual and expedite the sanctioning of these houses to ensure timely completion. The State Governments are requested to ensure sanctioning of the houses against targets allocated within 1 month i.e. by 1st October, 2024.
